eternal kingdom thru the merits of Jesus Christ  
our only Saviour and Redeemer.

2d I give and bequeath to my dear sons  
Henry and Robert my Fishing room and all  
Buildings thereon, to become their property so  
soon as they shall have paid the debt due to  
the firm of Bruce, Jones & Co. of Boston.

I give and bequeath to my sons Henry  
and Robert my Pew in the Church for the  
use of themselves and families, but not in

my account to be sold

I give and bequeath to the same my two  
sons my Fishing boat and Sinker Skiff  
also a Salmon net to each of them, and to  
Robert I give my largest Bed in addition to  
the one he usually sleeps on, the other two  
Beds I give to my son Henry

I request that my Goods shall be  
fairly and equally divided between the aforesaid  
Henry and Robert. I further request that my  
Watch shall be given to my son Henry, and  
my Looking Glals to Robert, and that my  
Household Furniture, Gardening utensils  
and Bed Linen shall be equally divided

between those my two sons, and my wearing  
apparel to be fairly divided between my three  
sons, John, Henry and Robert.

I hereby appoint Mr William Bell  
as

Andrews (Roberts son) and Mr John Tucker  
 (Charles son to be my Executor to see this  
 my last Will and Testament carried into  
 operation, and to see my mortal remains  
 decently buried the expenses of my funeral  
 to be defrayed by my two sons Henry  
 and Robert, in witness whereof I hereby  
 set my hand and seal this twenty-fifth day  
 of August in the year of our Lord one thousand  
 eight hundred and forty.
