24 last month neglect in heating mr BENGERS OVEN a terrible fire about 1 am
I waked out of my sleep and ran thro the fire in my shirt with 2 of my
children . my wife followed in her shift, but my son, the maid servant
and an apprentice boy were all consumed in the flames. The store hou-es
and dwelling houses were all entirely destroyed; and all the goods
furniture and provisions whatever, for not a single thing was saved.
Valuing my goods at prime cost I have lost full 2800L exclusive of the
buildings for I had in the Store 2400 qtuinals of dry fish which I purposed
to send to spain in the spinrg. Mr Benger and his family lost their all. and we
are reduced to the greatest distresses for Want of provisions and cloaths till we
had a supply from the neighbouring harbours
