and broke down the JUTSHAM HEIR MR FLOOD TERRIFIED THESE POOR INHABERS OF PORTUGAL COVE  
boundaries between the room and the meadow  
williams threatened hanlon with his horse whip  
and hanlon in fear surrendered his property meadows and gardens  
HAS WIFE AND 6 children almost starved since having no  
potatoes for their support or hay or oats for cattle  
WON AND L20 damages
