1803 17 jun sup ct corn for self and phil roche sued larkin/brennan of
placentia doe 52/10/3d blice a/c
arbitratation disallowed 24/12/- charged by roche on difference
between truck and bill price for FISH
and defendented had short credited palaitntiff 6d a qtl
on 213 qtls of madeira fish. and had short credited them 3 4/- qtl
on 236 qtls mchtable fish sold at stjns by DEFENDENTS.

1803 18 jun cent dist min bk CORN and phil roche sued larkin/brennan of Placentia
for 52/10/3d for blice of a/c . 24/12/- DISALLOWED as being difference
between (CHARGED BY DEFENDENTS) as being difference between truck and
bill sale for fish defendents had short credited 6d a qtl for 213 qtls
madeira and 4/-d per qtl on 236 qtls merchabl.e sold at stjns
by defendents

1806 23 jul placentia ct Corn illit jury indicted in murray for murder vil

HAWKINS

1819 30 sep placentia ct corn sued luke collins for damaging a pat. cont'd

hawkins

1820 11 aug placentia ct corn sued by fra bradshaw for 91/15/6 a/c to pay

HAWKINS

1820 12 sep placentia ct corn petition to court dealer to fra bradshaw
but was not supplied enough for fall fishery - and for 2 last summers
fell into debt to bradbshaw because his boat not amply supplied
had once to send beat to cape st marys (his usual ground) with
only one week provisisions . offered to deliver up his boat and craft
to bradshaw - sent his BOAT MASTER about this. had also been forced to
sign over house/garden. new in dread of starving.

HAWKINS

1821 13 jun placentia et corn sued luke collins for obstructing his path
court saws collins to haul down wood cut by hawkins (in 1818) whilst
he was ualing his wood on hawkins path

Hawkins

1821 13 jun plcentia et corn sued luke collins/3 others to haul his wood as earlier
decreed by court - to do so.

HAWKINS

1821 14 jun placentia et corn request jury (illiterate) choose others delaves.

hawkins

1821 14 jun placentia et corn illit coroners jury

HAWKINS

1821 22 jun placentia et Corn sued luke collins steph flinn robt patterson thos miller
for encroaching on his path - Jury gavenim L10 agst luke collins only

HAWKI NS

1821 22 jun placentia et corn sued luke collins/steph flinn robt patterson
thos millerfor spoiling a path of his and not obeying a decree
of 1819 awarded L10 by jury
