breach of contract through disobedience and drunkenness - had sent him
to st marys to extend the practice. jury says to pay 37/13/- over and
above 30/2/- which he had advanced rentoul during the service. *R. P. M. C. W.*

1819 2 aug ferryland And sued by fra rendell(holdsworth svt) for 1/1/- ~~for~~ medical
charges for which rendell(as entered on dr molloy books) was not
liable. court finds rendell to pay him 7/6 and capt bulley the rest

1819 13 sep ferryland AND JP heard a case involving law morrissey who stole
a little bread/biscuit fm HIS OWN HOUSE. -(found him gulty)

MORRISON
1819 10 nov ferryland and ferryland JP

MORRISON

1820 5 may ferryland ct and sued robt/jas carter for 12/3/- doctoring for their svts
they refused on grounds that they did not charge the svts WON

MORRISON

1820 4 nov ferryland ct and hired jas seburn as house svt in nov 1819 but he
no good - discharged him in may

MORRISON

1820 4 nov ferryland ct and sued david welsh for 4/1/- medical attendance
he a regular patient but through misconduct got VD and hence
extra charges 3/3/- to get 3/13/8d

Morrison

1820 9 nov ferryland ct and sued rich cullen for 1/4/- doctoring for 2 years
latter claimed he paid dr molloy won
sued mat mcdaniel for 1/11/6 3 yreas doctoring - mcdaniel said never employed him
and went to dr molloy. WON

1820 11 nov ferryland ct and sued mich mccarthy for 1/1/- 2 years doctoring
mccarthy siad when morrison absent in st jns had to go to molloy no proof
won
