agent in hr in selling bankfish caught by their vessel. then went with passengers
and oil to wtd sold it and took passage money - hid in ireland till spring then
went secretly to nfld. is to pay to conway heighington at hr grace.

1770 col recs JN 1 1767 wf Went as agent on a Banking/pass schr fitted out by
Jn/Ben Lowle of Brstl. caught 27500 fish, carried 80 pass fm
Waterfd - did not pay them - "secreted himself in some remote
part of ireland until the following spring" - then went secretly
to nfld - now at H/G. agreed to pay £100 p.a. but never has - he
to do so.
