The following instrument purporting to be a Bill of Sale of a Room, was this day recorded by me at the request of Mr. William Alexander Merchant, Bonavista

Keeper of the records

"Know all men by these Presents, That Thomas Newell, Int. of Trinity, in the Island of Newfoundland, Planters for and in consideration of sixty pounds Sterling which I am indebted to Mr. William Alexander of Bonavista, in the said Island, Merchant have bargained, sold, transferred and delivered, and by these presents according to the due form of Law do bargain, sell, transfer, and deliver unto him the said Mr. William Alexander, all my Plantation or Fishing Room situate, lying and being at the North side of Trinity Harbor, and known by the name of "Newell's Room", with every species of creature thereon. So have and to hold the said bargained Premises unto the said Mr. William Alexander, his heirs, executors administrators and assigns for ever. Notwithstanding upon the express condition that the said Thomas Newell, his heirs, executors, administrators or assigns may have the liberty of redeeming the said Plantation or Fishing Room, on paying or causing to be paid unto the said Mr. Wm. Alexander the sum of Sixty Pounds Sterling, or such sum or sums as I may at the time of redeeming the said Room be indebted unto him, his heirs, executors, administrators, or assigns. In Witness whereof I have hereunto set my hand and seal at Trinity in the Island of Newfoundland this twentieth day of April in the year of our said one Thousand eight hundred and twenty one"
