1799 6 dec sup ct JN sued creditors wm henley/co
in aug 1788 he boat keeper granted a plant Lillys plant in
stjohns because the yearbefore had spent much in erecting
billdings etc for the fishery
he in debt to henleys who had a mortgage it SOLD LATER on
their insolvency to c/ham bell and co - but sault alledges only
a mortgage till debt paid
he said would give up all right for L50.
in 1794 owed henley/co L512 and made overthe plant to them
he illiterate this done
