ALL HIS ENGAGEMENTS FOR THE DIRTY WORK they abused each other
BOTH GUILTY OF BREACHOFPEACE AND slanting others
SCOTT BRIBED BARR tohurt maddocks
SCOTT TO GIVE BOND FOR L500 to behave well for a year
and barry for L100
AND EACH FINED L10
