Sir,

We have been honored with your Excellency reply to our letter of the 15th. instant and we feel very confident that your Excellency will discharge the duty imposed on the High Office of Governor on the subject of our representation nevertheless in order that your Excellency may be enabled as far as the present circumstance of the case will admit to satisfy the enquiries of His Majesty's Ministers or any other sonstituted body, before whom our chargesvagainst the Chief Justice may hereafter be brought we take the liberty to suggest to your Excellency the propriety of gaining such imformation here, as may be furnishing by the testimony of respectable persons on the spot.

The further considerations of these casualties which no human effort can guard against will also suggest the necessity of the measure comtemplated.

The C_nief Justice has denied that he gave any orders to Mr George Lilly for the Sale and distribution of Thomsons effects. It will therefore be necessary to have Mr William Thomas and

Mr Lilly on those facts.

The mock trial between Mr Rennell and Mr Lilly is too notorious to be denied yet it will certainly be proper that a copy of the record in the Supreme Court, should be laid before the Government House.

In respect to the intended concealment of the registry of Mark Streets hond, we
suggest to your Excellency the expediency of examining at los
least confidentially Mr Carter Judge, of the Court of
Vice Admiralty, Mr Bland High Smeriff and Mr Lilly
the these Clerk of the Probate Court.

The nature of the transaction complained of, and the distance between this Island and theseatof Government at Homse point out the necessity of some such enquiry as we now beg leave to suggest and we have no doubt if your Excellency has not already anticipated those suggestions, that you will fully agree with us in the measure we propose.

The trial of the Civil action, in the matter of the Reardons took place in the Supreme Court on the 8th. August 1809, and we find in the record of that trial, a copy of a letter from the case Governor, dated the 19th. October following which is a proof that

the record of that trial could not be earlier than that date, and in all probability much later.

The Chief Justice kept his own records. If the Gentlemen composing the Jury that find the cause mere examined it would be discovered whether the records and the matter that cameeout on the trail correspond.

It will be proper we presume to ask some questions of Mr George Lilly respecting the fifty Guineas paid him in the above case by order of the Chief Justice as Mr Lilly declared that he made no charge and that the sum was certainly beyond his expectations.

We feel Sir, that our reputation as Merchants and as men, is at stake, we disdain every malicious or unworthy motive in the present enquiry and your Excellency will hardly blame our anxiety to leave nothing undone, which we conceive ought to be done to establish the truth of our charges against the Chief Justice of Newfoundland.

Excellency's letter dated the 13th. instant Stat. 50.

Geo. 3. Cap. 7. cannot be construed to extend to a person actually hired and employed in catching and curing Fish, during the Fishing Season, in Newfoundland so as to allow such servant to enlist, and be entitled to a proportion of his wages in terms of the 29th. Sec. of the said Statute.

I am inclined to admit that persons not actually employed as Servants in the Fishery and all persons not legally dired, and in the actual service and employ of a master; and generally all descriptions of persons between the first day of December, and the first day of March, may enlist without any material inconvenience to the Fishery.

I am clearly of opinion that the 130th. Section of the said Stat, has not extended the whole of the Act in all its bearings to any part of your Excellency's

Government; but that the 118th Sect. may be taken as a guide, in our construction of this Statute, and we are to consider the general regulations of the Act, as far as the same can be applied to complaints arising within this Island.
