1758 6 oct trinity ct RICH SR late of trinity greatly indebted to the principals of capt sampson mifflin, mr thos clark, capt wm taverner and capt hy brooks. he about to sell a boat of fish and oil here to defraud them they will prosecute him before mich gill v/adm court. effects to be seized

WATERMAN

1758 18 oct trinity ct Rich JR chosen constable for HOGS NOSE trinity hr in the room of RICH SR (replaced thos small)

1758 dec st jns ang MR RICH his d ann buried

I760 col recs RICH. "Through the mchts extravagant charges on their goods, the losses disappointment and other misfortunes which ie had met with he fell in debt in the sum of £640. Creditors now have all his property in TRINITY. BUT HE KEEPS HIS TILTING PLANT.

WATERMAN

I761-4 col recs RICH Planter TILTON HR. I761 sold plant there to Sam Jutsham for £500 - never go it. - in debt to jutsham.

1762 lester diary "young RICHARD" his stage burnt at trinity by french

1762 trinity ang rich married saran gillet

1762 trinity nth reg Rich married

1768 23 aug col recs rich sold 40 qtls fish, and oil by david bailey although bailey owed this fish to Lester.

1768 oct trinity ct rich planter of trinity at times had supplied david baily bonaventure planter with provs and clandestinely took 40 qtl (with bailey consent) when it owed to lester the current supplier. to deliver it up

1768 12 oct lester diary Rich/ ben lester went to court at trinity about his affair

1769 col recs RICH Trinity. fraudulently made off with goods owed to Lester.

WATERMAN

~~1768~~ 1769 5 oct trinity ct Rich planter pleads guilty of contemnt in refusing to make restitution to lester for the fraud he found guilty of in 1768 and also guilty of selling a skiff which had been seized to pay the above and seized by a constable Humbly begs pardon and byron pardens him

WATERMAN

1772 3 oct trinity ct rich planter of trinity employed wm hallahan an apprentice bound to serve pat mallone. to return him and pay his wages to malone

WATERMAN

1772 3 oct trinity ct Rich planter wants to build a fishery on ground in trinity that once belonged to his father 'seized foe debt/ burnt by french and now occupied may do so.

WATERMAN

1773 8 sep trinity ct Rich sued by jas morley. in 1763 morley leased him a room for 10 years rent free but to leave it in tenantable condition and build a store and cook room. had no done so. arbitrators award to build a store or pay L48 to morley

WATERMAN

1774 28 sep trinity ct rich complained that thos street brought a cask of goods out fm Poole for him - his clerk would not let him have it for being in debt Street ordered it to be given up on paying freight

WATERMAN

1774 1 oct trinity ct rich sued by jas morley for breach of agreement last year was to build a store on morleys room worth L48 or in default pay L20 store worth only L12. to pay the L20

1779 19 apr trinity ct rich of trinity planter convicted of selling liquor without a licence contrary to state 16 geo 2 c 40 fined L5 (first offence)
