they steered north to get round iton the 11th lost the rudder
against the ice. mate IS EASTMENT WENT on to ice to moore the vessel
with a tow line which slipped and left him on the ice - boat got out but
blowing too strong could not get him-he lost - he buried 3 days later at b/vist
on the 12th heavy gales/seas - all sails handed nearly 60 PASSENGERS striving
to keep the vessel fm being stove in by the ice, by cutting up small bower
cable. at 10 am moored her in the ice with the anchor - passengers left without
masters consent - he persauded a few to remain to save the vessel and cargo
they had to abandon her six miles fm b/vista and come ashore
