# BONNELL O WILLIGA LETTIN

One of the earliest settlers in Lamaline appears to be the Bonnells -possibly in the 1770's.Around 1812 Benjamin,Saul and James were living there.Mun folklore states the Bonnels settled at Lamds Cove and this appears to be correct as they were recorded there in 1816.

1860 William (born about 1790) lives four miles from Lamaline. 1787-8 Newmans Journal lists Robert of St. Lawrence dealing with the store there.

1806,7,11 Newmans Journal mentions dealing with Richard Junior and Senior and Robert Bonnell.

1795 There is a George at St. Lawrence. //Later in the 19th century Bonnells owned vessels in Lamaline. Robert, a planter, registered a 23 ton vessel in 1869, and Saul owned and captained the HARRIET, 18 tons and MARGARET ANN 18 tons, in 1852 and 1858.
