1820 7 jul hg surr ct PHILIP charged with contempt for refusing to deliver up premises at hr main sold at suit of trimminghams.co foreclosure, his wife prevented wm maloney constable frm getting into the room; HAD KEPT IT SINCE 1815 in defiance of judge, to get 36 lashes.given 12 and rest remitted. He quitted premises but his WIFE would not she refused entry to surrogate door broken down and she and some furntiure carried out, .

BUTLER

1820 4 nov sup ct Phil charged Capt Buchan and revd leigh JP for L500 for false imprisonment and flogging. JURY FOUND FOR DEFENCE.
