1821 15 jun placentia ct Luke sued by wm reily for insufficient supply which forcedhim to sell his boat court disagrees- is made up to avoid just payment of debt

1821 22jun placentia ct Luke/2 others sued by corn hawkins for spoiling a path and not obeying decree of 1818. jury says they to pay L10 damages. HE TO HAVE THE STUFF I SIDE AND OUT
