First, the schooner "NANCY" 1000 quintal capacity, and the schooner "SUSANNAH FORD" 800 qtls. capacity, fitted out for last year's sealfishery. Also they sell 1600 quintals of shore merchantable fish, 220 qtls. of Labrador fish, Newfoundland cure, 16 tons of cod oil and 2 tons of seal oil. They also sell their leasehold premises under lease from Emma Gaden (James Stuart is now the proprietor), sixteen years of which are unexpired, comprising a house, shop, stores, cellar and wharf, subject to the rent of £18. per annum, and also their interest in a wharf and platform adjoining the premises leased from Lawrence Barron for sixteen years at a rent of £20.
