The Memorial of Michael  
Jill to His Excellency the Hon<sup>ble</sup>  
Governor Byron.

Most Humbly Sheweth  
That your Memorialist came  
to this Island in the year 1721 and  
in the year 1733 had the honor  
of being commissioned for a  
justice of peace and in the  
year 1750 of being appointed a  
Commissioner of Oyer and  
Terminer and in 1756 Com-  
missary for the Island of  
Newfoundland at which time  
or soon after laid aside the  
Business or trade of mer-  
chandize that He might more  
diligently attend the public  
affairs which in the several  
Sessions came under His  
conjurance which he then hoped  
would be sufficient for a  
comfortable livelihood but  
has been greatly disappointed  
in His Expectation as the profits  
arising from the several offices  
does but little more than  
half amount to the supporting  
his family which is but  
small mostly occasioned  
by the poor circumstances  
of the people in this Island

who he verily thinks one out of  
 thirty of the complainants and  
 complainant of are not able to  
 pay the just wages or fees  
 that might be demanded <sup>with</sup>  
 He has been of any service to  
 the publick in keeping the  
 peace or preventing the many  
 disorders that would happen  
 or in his Behaviour in the  
 Execution of the trust reposed  
 in him He is willing to rely  
 on the opinion of your Excellency  
 our late Governor Tallisier & the  
 several Governors that has been  
 appointed in his Time & the  
 Trading people here.

Therefore prays if he may  
 be thought deserving that some  
 little pittance may be  
 allowed him during his  
 Life or while he is intrusted  
 with the several Honors con-  
 ferred upon him or that his  
 son may be appointed naval  
 Officer with the consent of  
 your Excellency and your  
 memorialist will ever pray
