GRAHAM
 1820 12 oct sup ct Arch sued for L3000 goods/fisihery supplies by hunters.
 had dealt with hunters since 1816 - always paid in the fall
 he admitted the debt but said it was not due till 31 oct.
 had already sent 1500 qtl to oporto and another cargo ready
 proceedsof these were to pay hunters. - LAST YEAR the blce due
 hunters had been L1000. TO PAY. always paid (say plaintiff)
 in GOODS AND NOT BILLS.

GRAHAM
 1820 12 oct sup ct Arch sued for L3000 for blce of 1819 and present a/c by hunters
 last years balance about L1000.
 started dealing with hunters in 1816
 was fishery supplies. this year had sent 1500 quintals to Oporto and had
 another cargo ready to go. contends debt not due till 31 oct. WINS
 always paid in produce of the country COURT FINDS FISH HAS BEEN SHIPPED
 OFF THUS DEBT NOW OWEABLE.

GRAHAM
 1820 30 oct trinity ct arch sued by his svt jn hennessy for seizing
 his chest and clothing. he not in trinity- postponed until 1 nov.
 then court says to hand them back.
 also sued by rich tobin for an assault- withdrew charge on condition
 that graham paid him the blce of wages to pay him off and see to his
 passage home.

GRAHAM

1820 9 nov trinity ct arch sued by hy pyne. pyne a dealer of graham- had hired a boat off him- claims overcharged. court finds for pyne

GRAHAM

1820 1 nov trinity ct arch sued by wm harris for L10 boat hire. harris one of his dealers- has already been credited with it. non suit suedbty HY Pynn for L10 boat hire. same result.

GRAHAM

1820 1 nov trinity ct arch sued sam sinyard for failing to pay a certain qty of fish annually to liquidate a debt to get it or sinyard will be sold up.
sued wm langer, jn pitcher, wm hull, jas wade and abram snelgrove for non performance of agreement to pay off debts at a certain amount p/a- authorised to derclare them insolvent as per mortgages

12 1820 4 nov trinity ct arch sued by mich dawley for refusing to pay him for fish other than in goods. court finds they had agree that fish was to be paid for in goods.

servant wages. CASE LOST. by hunters.
