Arthur Hunt verses Hunt, Stabb, Preston and Co. It is an ajetment bill to obtain a title together with possession of plantations in Newfoundland. It is an appealable case. Two of the defendants, Henry Hunt and John Hatnoble are concerned in trade in London under the firm of Noble and Hunt. And they are

also engaged together with Thomas Stabb and John Preston in Newfoundland, under the firm of Hunt, Stabb, Preston, and Co. Both firms had very extensive dealings together, in the course of which the defendants were in the habit of remitting the returns of their fishery to Noble and Hunt and drawing bills on them for the payment of the current demands of their establishment. In 1816, the Grafts of Hunt, Stabb, Preston, and Co. upon Noble and Hunt, were greater than they had the means of meeting and that Henry Hunt, the managing partner of Noble and Hunt applied to the complainant to advance money for the purpose of meeting the deafts. Complainant advanced about nine thousand pounds, but whether upon the credit of Noble and Hunt or Hunt, Stabb, Preston and Company, the former stating in his answer that the money was borrowed of the complainant on a mortgage of the property in Newfoundland and the latter denying that fact and affirming that it was the balance of an account current, solely between the complainant and Noble and Hunt. While the complainant appears from his affidavit to have considered he had a claim upon both firms. Be the fact, that it may, for the present, the complainant insisting upon having some security either from one or the other firm, deeds of mortgage of the property in question were prepared in London, and executed by three of the respondents, Hunt, Noble and Stabbian May, 1816 and sent forward to be executed by Preston, who was at that time in Newfoundland. It appears that Mr. Preston executed the reason himself, alledging as a reason, his apprehension of endangering the credit of their house by the necessary publicity of recording the deeds.

This is an extremely long judgement:

Mr. Preston believes on oath that the death of 7,280 pounds claimed to be due by the complainant was contracted with him on a running account prior to the year 1816, by the firm of Noble and Hunt solely upon their own credit and accounts. This however, is expressly denied by Mr. Hunt in his answer and he is corroborated by the entry in the books of the respondents at Torcee, and the depositions of Glever and Pittourn as to the circumstances in which the entries were made. Judgement of the court - I must comply with as much as the prayer of the bill as goes to the delivery of the possession of Adam's and Ladies Ship's Rooms together with the title deeds, but I must be understood not to pass any opinion upon the debt, whether it is the proper debt of the respondents or of Noble and Hunt.
