1769 25 mar lester diary THOS, lester's "old servant in the land" came to poole fm ireland
on a/c of some of jn churchills bill I gave him.

1769 25 mar ben lester thos came up to lens house- came fm cork with capt
churchill

KEDMAN

1769 9 jun ben lester . agreed with lester that lester woul supply his two boats
with bait at north side trinity.

1769 13 jul lester diary D went fishing in a skiff

KEDMAN

1769 30 jul lester diary D sent to dildo islands in a shallop for fish

KEDMAN

1769 26 aug lester diar K came to trinity fm riders hr with 245 qtl of jn hiscock

KEDMAN

1769 21 sep lester diary D sent to riders hr by lester

KIDMAN

1773 14 sep trinity ct THOS nth side planter his servants w^m hay boat master and 3 irishmen request security for their wages. they have no real cause to fear fraud but his circumstances are such that he is to deliver 100 qtl to ben lester as security. HE COMPLAINED LOST much through frequent drunkenness of boat crew can deduct 60/-d fm hay and one others wages.
