KELLEGREW
1803 14 nov ferland surr ct JN clerk fo hunt/stabb and co. he at renews. came fm there to ferryland in a sloop capt jn griffin. had a dispute with griffin over spreading a tarpaulin. Griffin took out a knife. kellegrew took up a shovel no inury. fined 6/8d for assault

KELLEGREW
1804 17 sep ferland surr ct JN sued for assault by wm west. JN agent to wm tucker sued for assault by wm west boat master to tucker. on 14 aug threw him down and thumped him with his knee. He said had been a scuffle when west refused to leave the house. plaintiff had been unwell ever since started employneb. Jury ac uits him. insufficient evidence.

KELLEGREW
1805 nov ferland surr ct sued TUCKER had been tuckers svt wanted bllice a/c/tucker owed him 54/5/-d, had been partner with tucker in a boat in the fishery to be arbitrated awarded 45/77/ 11d

kelligrew
1806/7paign jn married michael? goodridge

KELLEGREW
1807 nov ferland surr ct JN sued his svt sinnett for refusing to proceed fm bt johns in kellegrews boat in the fall. but this because no provs except a kettle of dirty bread non suited should have had provs for the voyage AND THE BOAT MASTER should have procured them.

KELLEGREW
1807 nov ferland surr ct JN suedby jas ryan boat master to dennis meaney of fermews kellegrew A MCHT BOAT KEEPER and also skipper of a bait boat. was giving biat to ryan when a disupte arose. kellegrew thrust at him and badly injured him with a boat hook off duty(see other case) kellegrew to pay surgeons fees and diet 10/10/- and fined L5. *DKATTY WAS OVER BOARDER BAIT.*

KELLEGREW
1807 nov ferland surr ct JN & HY sued by their current supplier arth holdsworth very considerable supplies recd and had recd fish/oil in part payment but they also dealing with hunt/stabb and. holdsworth to secure their debts on hearing this took out two writs for L229. court finds they very indebted svts wages not paid voyage delivered to different persons and THEY SENT 300 qtls to market on own a/c. A Bill drawn by them in spring returned protested. The fish shipped by them was to pay a debt in England. their property insufficient to pay 20/- in L declared insolvent (FURTHER PROCEEDINGS ON THIS BUSINESS WERE HAD IN THE SUPREME COURT)

KELLEGREW
1807 8 nov ferland surr ct sued kelly/mackie and doyle svts to JN white of Fermews who they supplied for refusing to let fish go fm whites room. they to get and take the fish and oil for wages

KELLEGREW
1807 9 nov ferland surr ct JN sued for assault by dennis meaney. meaney's svt a bt master was so hurt by kellegrew thrusting a boat hook against him as to be off duty fm 12 july-1 sep. fined damages by jury of L20

1813 paign jn/michal COOPER had son WM

1813 30 jun sup ct jn/hy sued for 85/19/10 by jas macbraire sent to ferryland

1814 14 nov sup ct jn jury

1818 29 mava iourn JN at renews sells schr jane 35 tons.

1820 2 dec st jns sup ct rowe and? sued thos ryan for L99 value of seals taken by their vessel and taken by crew of ryans. LOST

1820 2 dec sup ct rowe and sued thos Pynn for L99 supposed value of seals taken fm their vessel by pyms crew. LOST

1820 11 dec sup ct rowe and sued for 5/13/- by hy goodridge lost by default

1820 11 dec st jns sup ct rowe and sued for 5/13/- by hy goodridge. lost by default

KELLEGREW
1827 mar ledger JN ferryland pro desbarres address

KELLEGREW
1829 jan ledger JN 1827 asked for 8 acres at renews

KELLIGREW
1832 15 apr ferryland ct JN sued thos mccarthy for 6/6d blee for shop goods
WM(his son appeared) - mccarthy sold them 600 1 qtr hay
they sent the hay to st jns won

KELLIGREW
1832 22 apr ferryland ct JN sued chas mccarthy - cancelled
sued edw walsh cancelled

KELLIGREW
1834 ferryland ct JN renews constable

KELLIGREW
1835 23 feb ferryland ct JN assaulted in his house at renews by nich whelin- he did not appear-acquitted.

1844 15 feb milder Jane 2nd d of MR JN of paign married JN goodridge mcht at renews(ang)

KELLEGREW
1847 feb gaz JN of renews is winding up his business

1853 st jns ang JN died age 80
