 and lawfully entitled, under and by virtue of her late Father's
 Will, bearing date on or about the twelfth day of November,
 One Thousand eight hundred and fifteen, to all that
 Fishing room or Plantation, together with the Dwelling house,
 Store house, Garden, and all and singular the appurtenances
 thereto belonging, which said Premises are situate in
 Trinity aforesaid adjoining to a Fishing room occupied by John
 Bugden on the Southern part thereof and extending Northward
 in a straight line along the Landwash Thirty three feet, and
 on the Western part thereof Six hundred and twenty four feet,

And Whereas the said Sarah Triggs hath agreed to sell and dispose of the said Room and Premises above particularly described for the sum of Twenty Pounds Sterling, Now these Presents Witness that in consideration of the sum of Ten Pounds & two shillings paid by the said William Nelson to the said Sarah Triggs immediately on the signing hereof, and the further sum of nine Pounds & eighteen shillings to be paid to her on the thirtieth day of September next, she the said Sarah Triggs hath sold & assigned & transferred, and by these Presents doth sell assign & transfer to the S. W. Nelson, All her right title & interest in & to all & singular the S. Swill^g House, Storehouse, Garden & Premises above particularly described and in all and singular the Appurtenances thereto belonging.

To hold to the S. W. Nelson his Executors & assigns for & during the natural life of the S. Sarah Triggs, provided the term originally granted in the said lease shall not sooner expire, subject to the paym^t of the S. annual rent of Three Pounds Ster^g in the manner before mentioned, - and the first paym^t thereof to be made by the said W. Nelson on the twenty-eighth day of October next - And the said Sarah Triggs doth hereby agree to execute any further or other conveyance of the S. Premises hereby disposed of, if required so to do.
