Notice of a sale by -auction of Mr. James Melledge leasehold interest in the plantation at Riverhead containing about 11 acres of land with two dwelling houses, one of which is now occupied by George Bailey, Esquire, and the other lately occupied by George Holbrook, deceased, - spacious gardens and out-houses. The hall, held under lease from the late Garrett Keating for the term of 80 years from the 20th of May, 1810 -subject to an annual rent of £47. The house and premises occupied by Mr. Bailey are held by an unexpired lease from Melledge for 22 years from the 1st of May, 1815 at an annual rent of £50. sterling. Another part of the plantation containing about two acres is leased to Thomas McDonald for fifty years from 1819 at a rent of £15. on the front of which several substantial houses are erected. At the same time they will sell his interests in three acres of land adjoining the above held on a grant from the crown for thirty years at a rent of ten shillings per annum.
