belonging to ME salt/oil store and fishermans houses. a special commission was  
sent to bay bulls. decide the extra ground is part of property of LATE thos willian  
uncle to and Mary williams mother of mich brien. aTHIS ground unaccpied since fr  
burnt bay bulls in 1796.(temporary fishermen/shoresmens houses had been erected  
on it by murphy)  
DECISION Mich Brien allowed them to be unnocc for 20 years -  
Murphys had built for fishing purposes - court had sold it to driscoll etc  
they to keep.
