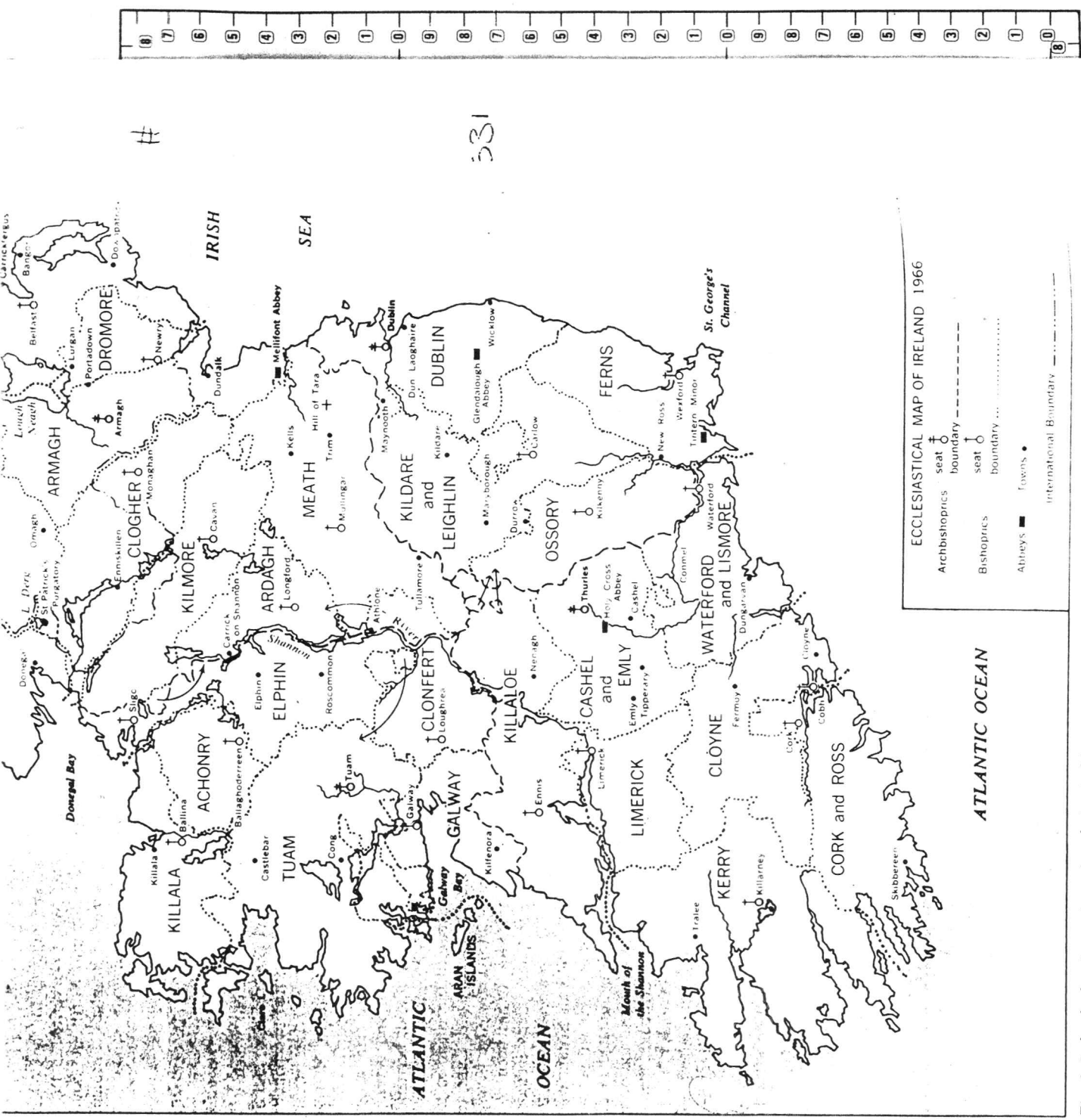


Fig. 1. Ireland, showing points of ecclesiastical interest.
