(re rich dene plantation to deliver up the house, garden to green and pay rent for the time he has possessed it. (THIS WAS DONE) 24 sep.

1700 2 oct trinity et thos or b/vist a partner of mr thos fitzgerald or wtd who got a lease fm rich dew to his plant in 1784. court finds that the house and garden are NOT part of the plant but to go to jn green. IF HE REFUSED to give up elias Jangdon JP to sell effects to pay green for his loss and green to be put into possession
