Christopher, Spurrier and Company at Oderin, comprising a house with offices and a frostproof cellar, provision store, three fish stores, pitch and salt stores, a "lin hay", two stages and lofts, carpenter's shop, cook-room, cooper's shop, flake and beach room for 500 quintals, a wharf 110 yds. long, a lathe store at Ship Cove with a wharf in front, 3 small tradesmen tenements, a stage on the South Side of the harbour, with flake and beach room for 300 quintals and a dwelling-house, cow house, 2 gardens, town house and a large copper boiler.
